## WEBSITE PRIVACY POLICY

### Data Controller Identity

It is a fundamental principle of our Company to safeguard the privacy of visitors ("Data Subjects" or "Visitors") to the website [www.eceboya.com](http://www.eceboya.com) operated by Ece Boya Kimya Sanayi Ve Ticaret Anonim Şirketi ("Ece Boya" or "Company"). Through the Website Privacy Policy ("Policy"), explanations are provided regarding the processing of personal data of data subjects and the enforcement of the Website Privacy Policy. Comprehensive information regarding the processing of personal data can be found in the Personal Data Protection and Processing Policy.

### Personal Data, Purposes of Processing and Transferring, Legal Basis, Collection Method, Recipient Groups

During your visit to our website, personal data such as cookies, etc., within the scope of Law No. 6698 on the Protection of Personal Data ("Law"), are not collected and consequently not transferred to any institution or individual. However, your identity and contact information, such as name, surname, telephone, and email, provided through the "Contact Us" section on our website, may be electronically processed in compliance with the Law and its fundamental principles. This processing is conducted for the purpose of facilitating communication activities, based on the legal ground that data processing is necessary for the legitimate interests of the data controller, provided it does not infringe upon the fundamental rights and freedoms specified in Article 5 of the Law, and shall not be transferred to any institution or organization.

### Rights of Data Subjects

- As a data subject, you are entitled to the following rights pursuant to Article 11 of the Law:
- To ascertain whether your personal data is being processed,
- To request information if your personal data has been processed,
- To be informed of the purpose of processing your personal data and whether they are used accordingly,
- To know the third parties to whom your personal data is domestically or internationally transferred,
- To request the correction of your personal data in case of incomplete or incorrect processing, and to demand notification of such correction to third parties to whom your personal data has been transferred,
- To request the deletion or destruction of personal data if the reasons necessitating its processing cease to exist, despite being processed in compliance with the
